

TURN ALLOTMENT OF NCC (SD/SW) TO INSTITUTIONS ON SELF-FINANCING
BASIS.**

1. Refer Govt of India, Min of Defence sanction letter No 4/7/2019-D(GS-VI) dated 13 Dec 2019.
